Dear Mr. Lovan:

My name is Blake Crawford, and my team has been retained by Sherrel Courvelle who resides at 249 Nathan Terrace, Jessieville, Arkansas 71949, which is next door to your facility.

Ms. Courvelle has made me aware of a variety of occurrences involving patients or agents of Sozo Addiction Recovery Center, hereinafter "Sozo", and her home and its occupants. Of note, I would like to bring your attention to the following:

- 1. Patients and/or agents of Sozo have trespassed upon my client's real property, including driving vehicles into her yard. During one past incident my client's canine was hit and killed;
- 2. Patients and/or agents of Sozo are wrongfully disposing of urine drug screening cups in my client's trash receptacle;
- 3. Patients and/or agents of Sozo have prevented mail delivery to my client's address by blocking the mailbox with trash and trash receptacles;
- 4. Patients and/or agents of Sozo are placing large objects of trash at the curb that the sanitation department will not pick-up as these objects must be personally taken to the county dump;
- 5. Patients and/or agents of Sozo are enticing my client's domesticated animals and livestock off property to feed and/or poison said animals;
- 6. Patients and/or agents of Sozo are roaming the properties at all hours of the night in violation of peace and dignity of my client and presumably your own curfew:
- 7. Patients and/or agents of Sozo have further trespassed by flying drones over my client's property;

- 8. Patients and/or agents of Sozo have engaged in intercourse next to my client's horse paddock; and
- 9. Patients and/or agents of Sozo have engaged in harassing behavior towards my client and her family.

Please consider this a good faith request to address the concerns outlined herein. My client does not wish you ill will, nor does she desire to escalate this developing situation. However, the behaviors detailed herein must stop.

If you are unwilling or unable to correct the wrongful behavior detailed herein, my client is prepared to seek all available legal remedies, including but not limited to, seeking criminal citation with the Garland County Sheriff's Office, filing a complaint with the State licensing body providing you with license, and/or seeking relief in Circuit Court.
